Mrs. Ergen is a citizen of the United States.

Telluray Holdings acquired 3,619,517 shares of Class A Common Stock of DISH Network on December 13, 2019, pursuant to the exercise of subscription rights as described under Item 4 below, with working capital. The aforementioned shares of Class A Common Stock were acquired for an aggregate purchase price of approximately \$643,344,064.

### **Item 4. Purpose of Transaction.**

As disclosed in the Current Report on Form 8-K filed by DISH Network with the Securities and Exchange Commission (the "SEC") on December 13, 2019, DISH Network announced that it has completed its previously announced rights offering (the "Rights Offering") as described in DISH Network's prospectus supplement dated November 22, 2019 and filed with the SEC on November 22, 2019 (together with the accompanying prospectus dated November 7, 2019, the "Prospectus"). On December 13, 2019, Mr. Ergen acquired 10,025,602 shares of Class A Common Stock pursuant to the exercise of subscription rights at a subscription price of \$33.52 per share of Class A Common Stock (the "Subscription Price"), in connection with the Rights Offering. On December 13, 2019, Mr. Ergen acquired 5,547,711 shares of Class A Common Stock pursuant to the Standby Purchase Agreement, dated November 21, 2019, between Mr. Ergen and DISH Network, at the Subscription Price, as described in the Prospectus. On December 13, 2019, Mrs. Ergen acquired 12 shares of Class A Common Stock pursuant to the exercise of subscription rights at the Subscription Price, in connection with the Rights Offering. On December 13, 2019, Telluray Holdings acquired 3,619,517 shares of Class A Common Stock pursuant to the exercise of subscription rights at the Subscription Price, in connection with the Rights Offering.
